Senate Bill 717 legislation that eliminates the requirement for nurse practitioners (CRNPs) to collaborate with physicians and allows them to practice independently remains awaiting consideration in the legislature. It's quite possible this bill could be considered by the Senate Consumer Protection and Professional Licensure Committee in the coming months.

Maintaining physician-led, team-based care in Pennsylvania remains a priority for the Pennsylvania Medical Society (PAMED), and we continue to strongly oppose this bill.

We urge all Pennsylvania physicians to do two things:

- 1. Contact your Senator and reiterate your opposition to SB 717.
- 2. Contact your local hospital administrator(s) and express to them that you oppose SB 717. On April 15, hospital administrators were invited to participate in a conference call with The Hospital and Healthsystem Association of Pennsylvania (HAP) to discuss whether or not individual hospitals will be actively supporting the independent practice of CRNPs in our state. More to follow.

With the complexity of our health care system ever increasing, patients need both physicians and nurse practitioners coordinating their care and sharing information for the benefit of the patient. The collaborative agreement ensures that patients have direct access to a physician when their care requires a more highly trained professional. Eliminating this network of support would not only be contrary to team-based medicine, but has the potential to jeopardize patient care.

GOVERNOR WOLF PROPOSES OPIOID USE DISORDER TREATMENT CENTERS IN 2016-2017 BUDGET; APPLICATIONS ACCEPTED NOW

Pennsylvania Governor Tom Wolf's proposed 2016-2017 budget includes \$34.2 million for the implementation of 50 centers that would coordinate care for more than 11,250 PA Medicaid patients with opioid-related substance use disorders.

The centers, called "Centers of Excellence (COEs)," would offer a patient-centered, team-based approach to help patients stay engaged in the treatment process. The goal of the centers is to integrate behavioral health, primary care, and substance use treatment.

PA's Department of Human Services (DHS) is now accepting applications for the creation of these COEs. Submissions will be accepted until 5 p.m. on May 6, 2016. DHS plans to select potential candidates by May 20 and make its final selections by June 17.

Organizations that wish to apply must:

- Either be enrolled as a Medical Assistance (MA) provider at the time of application or, if not currently an MA provider, must be enrolled by Sept. 1, 2016.
- Be willing to attest that they will not charge Medical Assistance recipients cash for any opioid use disorder related services.
- Have and make use of an Electronic Health Record within 18 months of being designated a COE.

DHS also says that it is highly recommended but not required that the COE obtain a patient-centered medical home (PCMH) certification from an accredited organization within 24 months of being designated a Center of Excellence.

DHS plans to award selected COEs \$500,000 in funding so that each COE can:

- Deploy a community-based care management team of licensed and unlicensed professionals.
- Track and report aggregate outcomes.
- Meet defined referral standards for drug and alcohol, as well as mental health, counseling.
- Report on standard quality outcomes.
- Participate in a learning network.

If the 2016-2017 enacted budget allows, DHS expects to implement phase one of the initiative on October 1, 2016.

PHASE 2 OF HIPAA AUDIT PROGRAM LAUNCHED -What Should Physicians Expect?

The Health and Human Services Office for Civil Rights (OCR) announced on March 21, 2016, that it has launched the second phase of its HIPAA Audit Program. OCR will review the policies and procedures adopted and employed by covered entities and their business associates to ensure that they meet the standards and specifications of the Privacy, Security, and Breach Notification Rules.

Most of the audits will be desk audits, although there will be onsite audits. OCR Director Jocelyn Samuels announced that there will be more than 200 desk and onsite audits, according to FierceHealthIT.

The first set of audits will be desk audits of covered entities, and a second round of audits will focus on business associates. OCR says desk audits will be completed by December 2016. A third set of audits will be onsite and will examine a broader scope of requirements from the HIPAA Rules than desk audits. Some desk auditees may be subject to a subsequent onsite audit.

Every covered entity and business associate is eligible for an audit. These include covered individual and organizational providers of health services, health plans of all sizes and functions, health care clearinghouses, and a range of business associates of these entities.

OCR has begun sending emails in order to obtain and verify contact information to identify covered entities and business associates to determine which are to be included in potential auditee pools.

Once contact information is obtained, a pre-screening questionnaire about size, type, and operations of potential auditees will be sent. The questionnaire will ask entities to identify their business associates.

What's the bottom line for physicians and practices?

Physicians and practices are encouraged to review spam or junk email folders to ensure that emails from OSOCRAudit@hhs.gov are not being classified as spam in error. Entities that do not respond may still be subject to an audit, and OCR will use publicly available information about the entity when creating its audit pool.

Practices may also want to prepare a list of business associates in order to be ready to provide this information on the pre-screening questionnaire.

HIPAA Resources from PAMED

OPIOID ABUSE

The problem: Opioid abuse and overdose is a growing epidemic. This crisis spans nearly every state in the U.S., but has hit Pennsylvania particularly hard. Nearly 2,500 deaths were reported in Pennsylvania as a result of drug overdoses in 2014, and more people die from drug overdoses than in car accidents.

The solution: A multi-pronged approach that includes physicians, patients, and health care organizations like the Pennsylvania Medical Society (PAMED) working collaboratively to address this increasing crisis.

PAMED, in collaboration with other stakeholders, has developed several resources to help Pennsylvania physicians combat the growing opioid abuse epidemic. Additional resources are in the works. They are the voluntary Opioid Prescribing Guidelines and the CME's addressing Pennsylvania's Opioid Crisis. Details are available on the PAMED Website.

Physician leaders will be adding an Opioid Awareness Day at the state Capitol. PAMED leaders will meet with legislators and/or their staff to talk about what PAMED has done so far to address the growing opioid abuse epidemic - including working with the state and other stakeholders to develop voluntary prescribing guidelines and continuing medical education for physicians - and more importantly, what it plans to do going forward to continue to educate physicians and empower patients.
